

**SECOND AMENDMENT TO AGREEMENT BETWEEN THE VILLIAGE OF OLYMPIA
FIELDS, IL AND REDFLEX TRAFFIC SYSTEMS, INC. FOR PHOTO RED LIGHT
ENFORCEMENT PROGRAM**

This Third Amendment (the “Third Amendment”) to Agreement between the Village of Olympia Fields, IL and Redflex Traffic Systems, Inc. for Photo Red Light Enforcement Program is made by and between the Village of Olympia Fields, IL (the “Customer”), and Redflex Traffic Systems, Inc. (“Redflex”) (individually referred to as a “Party” and together referred to as the “Parties”). The Effective Date of this First Amendment is March 11, 2020.

RECITALS

WHEREAS, the Parties executed the Exclusive Agreement between the Village of Olympia Fields, IL and Redflex Traffic Systems, Inc. for Photo Red Light Enforcement Program on September 1, 2011, which included the Renewal Contract Invoicing Form (the “Original Agreement”); and

WHEREAS, the Term of the Agreement was extended on August 14, 2014 on a month-to-month basis; and

WHEREAS, the Term of the Agreement was extended and Program changes and improvements were made on March 11, 2015 (“First Amendment”) (collectively, with the Original Agreement, the “Agreement”);

WHEREAS, the Camera Term for three (3) Existing Designated Intersection Approaches is scheduled to expire on March 10, 2020; and

WHEREAS, the Parties desire to extend the Camera Term for three (3) Existing Designated Intersection Approaches to coincide with the Camera Term end date for the New Designated Intersection Approach that went live on May 26, 2016 and has a separate Camera Term end date of May 26, 2021.

NOW THEREFORE, the Parties hereby amend the Agreement as follows:

TERMS AND CONDITIONS

- A. Term.** Section 2 of the Agreement is hereby amended to add the following language at the end of the section.

The Camera Term for the below Existing Designated Intersection Approaches are extended to May 26, 2021 to coincide with the end of the Camera Term for the New Designated Intersection Approach at Western Ave at Vollmer (NB):

1. Lincoln Hwy at Crawford/Governors HWY (WB);
2. Lincoln Hwy at Orchard Ave (WB); and
3. Lincoln Hwy at Western Ave (EB).

- B. Notices.** Section 11.1 of the Agreement is hereby amended to change the Notice address for Redflex to the following:

- C. **Enforceability of Non-Amended Terms and Conditions.** Except as expressly amended in this Second Amendment, the Terms and Conditions of the Agreement shall remain in full force and effect. To the extent that this Second Amendment conflicts with the terms of the Agreement, this Second Amendment shall control. Any capitalized terms not defined in this Second Amendment shall have the meanings ascribed to them in the Agreement.
