**AN ORDINANCE ABATING THE 2020 TAX LEVY FOR  
THE 2010 GENERAL OBLIGATION BONDS OF THE  
VILLAGE OF OLYMPIA FIELDS**

**WHEREAS**, on February 22, 2010, the President and the Board of Trustees of the Village of Olympia Fields, Illinois, enacted Village of Olympia Fields Ordinance No. 2010-04, "An Ordinance Authorizing the Issuance of General Obligation Bonds (Alternate Revenue Source) of the Village of Olympia Fields, Cook County, Illinois, in an Aggregate Principal Amount Not to Exceed \$1,585,000"; and

**WHEREAS**, the Village of Olympia Fields, pursuant to Ordinance No. 2010-04, issued the Village's 2010 General Obligation Bonds, in the amount of \$1,550,000 (the "2010 Bonds"); and

**WHEREAS**, Ordinance 2010-04 provides for the levy of a direct annual tax on all taxable property within the Village; and

**WHEREAS**, the corporate authorities of the Village of Olympia Fields have determined that the sum of \$57,200.00 levied for the debt service due and owing for the 2010 Bonds for the 2020 tax levy year, was available from other sources to make the payment of the principal and interest due on the 2010 Bonds for the 2020 tax levy year.

**NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OLYMPIA FIELDS, COOK COUNTY, ILLINOIS, as**

follows:

**SECTION 1:** The \$57,200.00 tax levied for the year 2020 for the purpose of paying the principal and interest on the 2010 Bonds as provided in Village Olympia Fields Ordinance 2010-04 is hereby abated.

**SECTION 2:** The Clerk of the Village of Olympia Fields shall be and hereby is directed to file a certified copy of this Ordinance with the County Clerk of Cook County upon adoption and execution of this Ordinance.

**SECTION 3:** The County Clerk of Cook County shall be and hereby is directed to make a tax abatement from the tax levied by Village of Olympia Fields Ordinance No. 2010-04 for the 2020 tax year levy in the amount of \$57,200.00.

**SECTION 4: Effective Date.** This Ordinance shall be in full force and effect from and after its passage and approval, and shall subsequently be published in pamphlet form as provided by law.

THIS ORDINANCE IS ADOPTED AND APPROVED BY THE PRESIDENT AND VILLAGE BOARD OF THE VILLAGE OF OLYMPIA FIELDS THIS 15th DAY OF March, 2021.
