**AN ORDINANCE ABATING THE 2020 TAX LEVY FOR
THE 2011 A & B GENERAL OBLIGATION BONDS OF THE
VILLAGE OF OLYMPIA FIELDS**

WHEREAS, on April 25, 2011, the President and the Board of Trustees of the Village of Olympia Fields, Illinois, enacted Village of Olympia Fields Ordinance No. 2011-10, "An Ordinance Providing for the Issuance and Sale of \$2,845,000 General Obligation Bonds (Alternate Revenue Source) Series 2011 A & B of the Village of Olympia Fields, Cook Count, Illinois"; and

WHEREAS, the Village of Olympia Fields, pursuant to Ordinance No. 2011-10, issued the Village's 2011 General Obligation Bonds, in the amount of \$2,845,000 (the "2011 Bonds"); and

WHEREAS, Ordinance 2011-10 provides for the levy of a direct annual tax on all taxable property within the Village; and

WHEREAS, the corporate authorities of the Village of Olympia Fields have determined that the sum of \$205,493.76 levied for the debt service due and owing for the 2011 A & B Bonds for the 2020 tax levy year, was available from other sources to make the payment of the principal and interest due on the 2011 Bonds for the 2020 tax levy year.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OLYMPIA FIELDS, COOK COUNTY, ILLINOIS, as follows:

SECTION 1: The \$205,493.76 tax levied for the year 2020 for the purpose of paying the principal and interest on the 2011 A & B Bonds as provided in Village Olympia Fields Ordinance 2011-10 is hereby abated.

SECTION 2: The Clerk of the Village of Olympia Fields shall be and hereby is directed to file a certified copy of this Ordinance with the County Clerk of Cook County upon adoption and execution of this Ordinance.

SECTION 3: The County Clerk of Cook County shall be and hereby is directed to make a tax abatement from the tax levied by Village of Olympia Fields Ordinance No. 2011-10 for the 2020 tax year levy in the amount of \$205,493.76.

SECTION 4: Effective Date. This Ordinance shall be in full force and effect from and after its passage and approval, and shall subsequently be published in pamphlet form as provided by law.
