ORDINANCE #2022-09

**AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE VILLAGE OF
OLYMPIA FIELDS FOR THE 2022-2023 FISCAL YEAR**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF OLYMPIA FIELDS, ILLINOIS, AS FOLLOWS:**

SECTION 1: The annual budget of the Village of Olympia Fields, for the 2022-2023 fiscal year is hereby approved. A copy of the budget is attached to this Ordinance. The annual budget of the Olympia Fields Public Library Board for the 2022-2023 fiscal year, which is attached to this Ordinance and made a part of the Village's budget, is hereby approved.

SECTION 2: The expenditures authorized for salaries and wages of the employees and officers of the Village of Olympia Fields shall not be considered as contracts or commitments. Expenditures under such accounts shall be further limited to employment of personnel only as needed or as may be required under the titles of positions specified. No officer or employee shall have the right to demand continuous employment and compensation by reason of the appropriation if it becomes necessary, on account of lack of work, lack of funds, or other reasons, to reduce personnel. In case of any vacancy in any office or position, the office or position need not be filled if there is no necessity therefore.

SECTION 3: A public hearing on the proposed 2022-2023 budget was held on April 27, 2022, prior to its approval and after notice was published in accordance with applicable law; the Village Clerk made the tentative budget available for public inspection at least ten days prior to passage of the annual budget on the Village website.

SECTION 4: The invalidity of any section, clause, paragraph, sentence, or provision of this Ordinance shall not affect the validity of any other portion of this Ordinance.

SECTION 5: The Village Clerk is hereby directed to file a certified copy of the Ordinance as approved in final form with the County Clerk of Cook County, Illinois, on or before April 27, 2022.

SECTION 6: This Ordinance shall be in effect from and after its passage and approval.
