ORDINANCE NO. 2023-02

AN ORDINANCE AMENDING
SECTION 21-32 OF THE OLYMPIA FIELDS VILLAGE CODE,
“REGULATION OF POTABLE WATER SUPPLY WELLS”

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OLYMPIA FIELDS, COOK COUNTY, ILLINOIS, as follows:

Section 1: **Amendment.** Section 21-32 of the Olympia Fields Village Code, “Regulation of Potable Water Supply Wells,” is hereby amended to provide as follows: [In subsection (a), paragraph (2) definition of “Potable Water”, in addition to the changes set forth in subsection (b) new language highlighted].

Sec. 21-32. Regulation of potable water supply wells.

(a) *Definitions.* For the purpose of this section, unless the context requires otherwise, the following terms shall be construed as hereon defined:

(1) “Person” shall mean any individual, partnership, co-partnership, firm, company, limited-liability company, corporation, association, joint stock company, trust, estate, political subdivision, or any other legal entity, or their legal representatives, agents, or assigns.

(2) “Potable Water” is any water used for human or domestic consumption, including, but not limited to water used for drinking, bathing, swimming, washing dishes, or preparing foods.

(b) *Use of groundwater as a potable water supply prohibited.* The use or attempt to use groundwater as a potable water supply within the corporate limits of the Village of Olympia Fields (i) in the area designated in Exhibit A attached to Ordinance No. 2013-14, and made a part hereof, which surrounds and includes the property known as 3602 West 211th Street, Olympia Fields, IL, and (ii) in the area designated in Exhibit 1 attached to Ordinance No. 2023-02 and made a part hereof, which surrounds and includes the property known as 3780 Lincoln Highway, by the installation or drilling of wells or by any other method is hereby prohibited. This prohibition expressly applies to the Village of Olympia Fields and any other unit of local government.

(c) *Penalty.* Any person violating the provisions of this section shall be subject to a fine of not less than fifty dollars (\$50.00) nor more than seven hundred fifty dollars

(\$750.00) for each such violation. A separate violation shall be deemed committed on each day during or on which a violation occurs or continues.

Section 2: **Area Exhibit.** Attached to this Ordinance as **Exhibit 1** is the designated area which surrounds and includes the property known as 3780 Lincoln Highway.

Section 3: **Repealer.** All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed insofar as they are in conflict with this Ordinance. Without limitation, Ordinance No. 2022-17 is hereby repealed.

Section 4: **Severability.** If any provision of this Ordinance or its application to any person or under any circumstance is adjudged invalid, such adjudication shall not affect the validity of the Ordinance as a whole or of any portion not adjudged invalid.

Section 5: **Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
