#### **Event Permit Application**

#### **Event Permit Application**

Approval of the event permit application of Scott Mehaffey, National Trust for Historic Preservation, for the 2023 Midcentury Modern Road Rally Tour of Homes on June 23–24, 2023.

Mr. Scott Mehaffey addressed the Board regarding the event application, noting that the event would feature homes on Country Club Drive, Hellenic Drive, and Oak Lane as well as in the Graymoor subdivision.

President Burke and several trustees expressed concerns about traffic control/police coordination, parking, and communications to the residents who would be immediately impacted by the tour. Concerns were also raised about the best use of tour trolleys. A lengthy discussion ensued about these concerns and possible solutions. President Burke asked Mr. Mehaffey to work with Trustee Oliver (chair of the Public Safety Commission) and the Olympia Fields Police Department to resolve issues related to tour routes, traffic control, parking, and related matters. Trustee White volunteered to assist Mr. Mehaffey with communications to residents about the event.

Trustee Blackwell moved, seconded by Trustee White, to conditionally approve the event permit application of Scott Mehaffey, National Trust for Historic Preservation, for the 2023 Midcentury Modern Road Rally Tour of Homes on June 23–24, 2023, contingent on Mr. Mehaffey reporting back to the Board at the June 14, 2023, Board of Trustees meeting with a detailed plan addressing the major areas of concern—traffic control, police coordination, parking, and communications to residents.
