**AN ORDINANCE AMENDING VARIOUS ORDINANCES IN CONNECTION
WITH THE VILLAGE OF OLYMPIA FIELDS APPROVAL OF
GOVERNORS HIGHWAY / VOLLMER ROAD TIF DISTRICT #2**

WHEREAS, the President and Board of Trustees of the Village of Olympia Fields adopted the following Ordinances in connection with Governors Highway / Vollmer Road Tax Increment Financing District:

A. Ordinance No. 2022-11, “An Ordinance Approving the Village of Olympia Fields Governors Highway / Vollmer Road Tax Increment Financing District Redevelopment Plan and Program”;

B. Ordinance No. 2022-12, “An Ordinance Designating the Village of Olympia Fields Governors Highway / Vollmer Road Tax Increment Financing District Redevelopment Project Area”; and

C. Ordinance No. 2022-13, “An Ordinance Adopting the Village of Olympia Fields Governors Highway / Vollmer Road Tax Increment Financing District”; and

WHEREAS, these three Ordinances are collectively referred to herein as the “TIF 1 Ordinances”; and

WHEREAS, the Village has subsequently adopted a series of ordinances approving Governors Highway / Vollmer Road TIF District #2 (the “TIF 2 Ordinances”); and

WHEREAS, the TIF 2 Ordinances comprise certain properties which are in TIF 1; and

WHEREAS, the President and Board of Trustees have determined that it is reasonable and appropriate to remove the TIF 2 properties from TIF 1;

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Olympia Fields, Cook County, Illinois, by and through as follows:

Section 1. TIF 1 Ordinances Amended. The TIF 1 Ordinances are hereby amended by removing the following properties from the TIF 1 District. Said properties identified by the Permanent Tax Index Number (PIN):

- 31-14-101-005
- 31-14-102-007
- 31-14-102-008
- 31-14-102-009
- 31-14-102-010
- 31-14-102-011

Section 2. Effective Date. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
